I Write Mines is a coaching workshop for books, songs and scripts. Mr AP questions, grades and walks a writer through the process — it never writes the work for them. The self-serve plans (Beta, Pro at \$12/mo and Premium at \$25/mo) cover individual writers. This sheet covers teams: studios, labels, publishers, schools and any organisation that needs seats, shared rooms, pooled concept runtime, and an invoice instead of a card.

Every rate here is list price. Final pricing is quoted in writing, and nothing is charged until a quote is signed.
